ARTICLE IV - MEMBERSHIP

Section 1. Eligibility

- A. Any woman believing in the philosophy of the Republican Party and in the objectives of this organization shall be eligible for regular membership. She shall be a registered voter.
- B. Dues must be paid for a minimum of thirty (30) days for an active member to enjoy voting privileges.
- C. Any man believing in the philosophy of the Republican Party and in the objectives of this organization shall be eligible for associate membership. He shall be a registered voter.

Section 2. Classifications of Membership Active (Regular) Members

- Any woman who has attained voting age, believes in the philosophy of the Republican Party and the objectives of the local club, and who pays the required annual dues, is classified as an Active Member.
- An Active Member may be counted in only one local club for the purposes of delegate representation to TFRW or NFRW meetings or conventions, and this will be the only local unit in which she may hold office.
- Her name, address and contact information shall be submitted to the TFRW from her primary local unit only.
- Her per capita dues to the TFRW and the NFRW shall be paid from her primary local unit only.

Associate Members

- A Republican woman who is a regular member of another Federated local club and wishes to support the Lost Pines Republican Women (LPRW) may be eligible for Associate Membership upon payment of required annual dues.
- Republican men who have attained voting age are eligible for Associate Membership upon payment of the required annual dues.
- Permanent Residents (Green Card holders) who have attained voting age are eligible for Associate Membership upon payment of the required annual dues.
- Associate Members may attend meetings, but cannot hold office, vote, or have voice. They cannot be counted for the purpose determining the number of delegates to TFRW or NFRW meetings or conventions.
- Men who are Associate Members are not eligible for membership in the State or National Federation.

Rationale: Green card holders can donate to campaigns at all levels, can participate in the political process, but cannot vote. To make them eligible, the requirement for men to be registered voters needs to be removed from our bylaws. As well, for female green card holders to be eligible, a specific bullet point needs to be added. Nothing in TFRW or NFRW bylaws preclude these individuals from associate membership. This change has been approved by the Executive Board.
